COBALT IN JUNE 2017

U.S. cobalt consumption and stocks in June 2017 will be published in a subsequent issue. The amount of cobalt contained in U.S. imports of cobalt metals and chemicals in January through June 2017 was 12% more than that imported during the same period in 2016 (table 2). The amount of cobalt contained in U.S. exports of unwrought cobalt and chemicals in January through June 2017 was 27% more than that exported during the same period in 2016 (table 4).

Prices

In June, the monthly average U.S. spot cobalt price was 7% higher than that in May 2017 and 156% higher than that in January 2016. The monthly average London Metal Exchange Ltd. (LME) cash mean price was 5% higher than that in May

2017 and 148% higher than that in January 2016. The following listed prices are for cobalt metal in June, in dollars per pound.
