IRON ORE IN SEPTEMBER 2017




Figure 1. Monthly domestic production, shipments, and stocks of iron ore from September 2015 through September 2017.

U.S. mine production and shipments of iron ore in September 2017 were 4.18 million metric tons (Mt) and 5.38 Mt, respectively (fig. 1, table 1). Average daily production of iron ore was 139,000 metric tons (t), 13% greater than that of August and 27% greater than that of September 2016. Average daily shipments of iron ore were 179,000 t, 7% greater than those in August and 36% greater than those in September 2016. Mine stocks at the end of September 2017 were 16% less than those held at the end of September 2016.




Figure 2. Monthly domestic imports and exports of iron ore and spot prices for iron ore import fines, 62% iron content CFR, at Tianjin Port, from September 2015 through September 2017. Source: U.S. Census Bureau and Index Mundi, undated.

Monthly iron ore data are reported as gross weight unless otherwise noted and do not include iron metallics such as pig iron, direct-reduced iron, hot-briquetted iron, or iron nuggets. U.S. exports of iron ore totaled 1.20 Mt in September 2017, 23% less than those in August 2017 and 10% greater than those in September 2016. U.S. imports of iron ore totaled 178,000 t in September 2017, less than one-half those in August and 33% less than those in September 2016 (fig. 2).
