MAGNESIUM IN THE SECOND QUARTER 2013

U.S. magnesium exports in the first half of 2013 were 5% more than exports in the first half of 2012. Mexico (14%), Singapore (11%), Brazil (9%), and Canada (8%), were the principal destinations. Exports of alloys and crude metal increased by 69% and slightly, respectively, but were partially offset by decreased exports of scrap (84%) and semifabricated magnesium materials (8%).

Magnesium imports for consumption in the first half of 2013 were 19% less than imports in the first half of 2012. Israel was the source of 65% of imported magnesium metal, down from 88% in the first half of 2012. Russia (11%), Canada (10%), Brazil (7%) and Kazakhstan (7%) were the other principal sources of magnesium metal imports during the first half of 2013. Scrap accounted for 38% of total magnesium imports, 42% of which came from Canada. Crude metal and alloys accounted for 32% and 28%, respectively, of all magnesium imports during the first half of 2013.

The quoted U.S. magnesium price ranges (table 2) declined by about 4% during the second quarter of 2013, and those in China and Europe declined by about 8% and 9%, respectively. The prices in China and Europe began to decline in mid-May and continued to decline through the end of the quarter. Abundant supplies of magnesium and stagnant global demand were cited as the reasons for the price declines (McBeth, 2013; Yee, 2013b). Magnesium metal exports from China during the first half of the year, however, increased by 21.3% compared

with those of the first half of 2012. Of the 106,000 tons exported during the first half of 2013, 31% was shipped to the Netherlands. Japan (10%) and Canada (8%) were the other leading destinations for Chinese magnesium exports. Exports of magnesium alloys during the first half of the year were 50,200 t, 3.9% lower than those in the first half of 2012 (Yee, 2013a).

The U.S. Department of Commerce, International Trade Administration, imposed an anti-dumping duty of 339.60% ad valorem on imports of pure magnesium from China by Tianjin Magnesium Metal Co. Ltd. and an affiliate, Tianjin Magnesium International Co. Ltd., between May 1, 2011, and April 30, 2012 (U.S. Department of Commerce, International Trade Administration, 2013).
