MAGNESIUM IN THE THIRD QUARTER 2016

U.S. magnesium exports in the first three quarters of 2016 were 15% more than exports in the first three quarters of 2015. Canada (52%) and Mexico (29%) were the principal destinations. Exports of alloys increased by 15% but exports of metal decreased by 13%. Magnesium imports for consumption in the first three quarters of 2016 were 6% more than imports in the first three quarters of 2015. Israel was the source of 70% of imported magnesium metal and Russia was the source of 11%. Scrap accounted for 45% of the imports in the first three quarters of 2016, 44% of which came from Canada, and 24% came from the United Kingdom.




Figure 1. Quarterly imports of magnesium metal from the third quarter 2014 through the third quarter 2016. Source: U.S. Census Bureau.

Although the U.S. spot Western price range for magnesium was unchanged, U.S. spot dealer prices for imported magnesium decreased by 3% during the third quarter of 2016, continuing the

decline from October 2014. Average daily magnesium prices in China increased by 13% during the third quarter of 2016 (table 2). Average daily magnesium prices in Europe increased throughout the quarter, and were 9% higher at the end of the third quarter than those at the end of the second quarter.

Update

US Magnesium LLC shut down an undisclosed amount of magnesium capacity at its Rowley, UT, smelter after Allegheny Technologies Inc. (ATI) shut down an adjacent titanium sponge plant in August. Consequently, US Magnesium announced that completion of expansion of its magnesium smelter to 76,500 metric tons per year (t/yr) from 63,500 t/yr would be delayed until at least 2018 (Maltais, 2016; US Magnesium LLC, 2016).
