MAGNESIUM IN THE THIRD QUARTER 2018




Figure 1. Quarterly imports of magnesium metal from the third quarter 2016 through the third quarter 2018. Source: U.S. Census Bureau.

Magnesium imports for consumption in the third quarter of 2018 were 4% less than imports in the second quarter of 2018 and 13% more than those in the third quarter of 2017. Compared with those in the second quarter of 2018, imports of metal, alloys, and semifabricated products decreased by 14%, 20%, and 31%, respectively, but imports of scrap increased by 15%. Compared with those in the third quarter of 2017, imports of metal decreased by 23% but imports of alloys, semifabricated products, and scrap increased by 98%, 10%, and 35%, respectively. In the third quarter of 2018, magnesium metal accounted for 30% of the imports with Israel (63%), Russia (15%), Turkey (9%), and Canada (9%) being the leading sources (fig. 1). Scrap accounted for 51% of the imports in the third quarter of 2018, with Canada (36%), China (21%), and the Mexico (19%) as the leading sources (table 1).

U.S. magnesium exports in the third quarter of 2018 were 14% less than exports in the second quarter of 2018 and 11% less than those in the third quarter of 2017. Canada (36%), Mexico (31%), and Brazil (22%) were the principal destinations. Exports of metal, alloys, semifabricated products, and scrap decreased by 29%, 4%, 18%, and 65%, respectively, compared with exports in the second quarter of 2018. Compared with those in the third quarter of 2017, alloys exports decreased by 11%, and exports of metal, semifabricated products, and scrap decreased by 53%, 14%, and 76%, respectively, (table 1).

The U.S. spot Western average price for magnesium was unchanged in the third quarter 2018. The average U.S. spot dealer price for imported magnesium increased slightly during the third quarter 2018. Outside of the United States, average magnesium prices in China and Europe increased by 5% and 8%, respectively, during the quarter (table 2).

Update

On November 15, the U.S. Department of Commerce initiated antidumping and countervailing duty investigations to determine if magnesium imported from Israel was sold at less than fair value or unfairly subsidized. US Magnesium LLC filed a complaint alleging dumping and subsidies of magnesium from Israel. If the investigation determines that dumping occurred or that unfair subsidies were provided to Dead Sea Magnesium Ltd., and if the U.S. International Trade Commission determines that the industry in the United States was harmed by the imports, duties will be imposed. A preliminary countervailing duty determination was expected by January 17, 2019, and the preliminary antidumping determination was expected by April 2, 2019 (McBeth, 2018; U.S. Department of Commerce, 2018).
