MAGNESIUM METAL IN THE FIRST QUARTER 2021

Total magnesium metal imports for consumption in the first quarter of 2021 were 14,400 metric tons (t), 9% less than imports in the fourth quarter of 2020, 34% less than those in the first quarter of 2020, but 3% more than those in the first quarter of 2019 (table 1).




Figure 1. Quarterly imports of magnesium metal from the first quarter of 2019 through the first quarter of 2021. Source: U.S. Census Bureau.

Compared with those in the fourth quarter of 2020, imports of alloys, semifabricated products, and scrap decreased by 18%, 33%, and 4%, respectively, and imports of metal decreased slightly. In the first quarter of 2021, magnesium metal accounted for 31% of the imports, with Turkey (42%), Russia (35%), and Israel (12%) being the leading sources (fig. 1). Scrap accounted for 41% of the imports in the first quarter of 2021, with Canada (43%), Mexico (20%), and China (11%), as the leading sources. Alloys accounted for 23% of the imports, with Taiwan (24%), Germany (15%), the Republic of Korea (13%), and Czechia (11%) as the leading sources (table 1).

Total magnesium metal exports in the first quarter of 2021 were 69% less than exports in the fourth quarter of 2020, 48% less than those in the first quarter of 2020, and 34% less than

those in the first quarter of 2019. Exports of metal, alloys, semifabricated products, and scrap decreased by 92%, 38%, 23%, and 46%, respectively, compared with exports in the fourth quarter of 2021 (table 1). Canada (64%), Israel (7%), Serbia (7%), Mexico (5%), and Czechia (3%) were the leading export destinations in the first quarter of 2021. Canada received 96% of metal, 94% of alloy, 16% of semifabricated product, and 49% of scrap exports. Israel received 32% of semifabricated product exports. Czechia and Serbia received 12% and 27%, respectively, of scrap exports.

The U.S. spot Western average price for magnesium was unchanged in the first quarter of 2021. The average U.S. spot dealer price for imported magnesium decreased slightly during the first quarter of 2021. In Europe, the average price was slightly more at the end of the quarter compared with that of the beginning of the quarter (table 2).

Update

Construction of a secondary magnesium smelter by Alliance Magnesium Inc. was nearing completion, with trial production scheduled for May. The 18,000-metric-ton-per-year secondary smelter located in Asbestos, Quebec, Canada, would start commercial production by the end of June (McBeth, 2021).
