MANGANESE IN MARCH 2022




Figure 1. Monthly imports of manganese (Mn) ore from March 2020 through March 2022. Source: U.S. Census Bureau.

On a gross-weight basis, U.S. imports of manganese ore in March 2022 were 449 metric tons (t), considerably less than the 46,300 t in February 2022 (fig. 1, table 5). However, total imports of manganese ore for the first three months of 2022 were only slightly less than those during the same period in 2021. In March 2022, the sole source of manganese ore, >20% -<47% grade, was South Africa and the sole source for >47% grade was Mexico.

Prices




Figure 2. Average monthly spot prices for manganese (Mn) ore delivered to China from March 2020 through March 2022. Source: CRU Group.

In March 2022, the average spot prices for manganese ore deliveries to China were \$5.21 per metric ton unit, 36%–38% grade, and \$6.86 per metric ton unit, 44% grade, 14% more and 23% more, respectively, than the February 2022 prices (fig. 2,

table 1). Compared with the monthly average prices in March 2021, the 36%–38%-grade price was 5% more, and the 44%-grade price was 27% more.
