TUNGSTEN IN AUGUST 2017

U.S. net production of intermediate tungsten products, including metal powder and tungsten carbide powder, was withheld to avoid disclosing company proprietary data.

The amount of tungsten contained in U.S. imports of selected materials in January through August 2017 was 56% more than that imported during the same period in 2016 (table 2). The amount of tungsten contained in U.S. exports of selected materials in January through August 2017 was 30% more than that exported during the same period in 2016 (table 3).
