TUNGSTEN IN NOVEMBER 2019

U.S. net production of intermediate tungsten products, including metal powder and tungsten carbide powder, was withheld to avoid disclosing company proprietary data.

The amount of tungsten contained in U.S. imports of selected materials in January through November 2019 was slightly less than that imported during the same period in 2018 (table 2). The amount of tungsten contained in U.S. exports of selected materials in January through November 2019 was 10% less than that exported during the same period in 2018 (table 3).

Prices

Weekly average prices for ammonium paratungstate, as reported in Platts Metals Week, decreased in late October 2019. The November monthly average price was 7% lower than that of October 2019 and 22% lower than that in November 2018. Platt's weekly prices for tungsten concentrates remained unchanged. The November 2019 monthly average price was 18% lower than that in November 2018. The following prices

for November 2019, in dollars per metric ton unit, were converted from short-ton-unit prices and rounded to the nearest dollar:

Ammonium paratungstate, U.S. free market:

Low—\$276/metric ton unit WO₃ (\$250/short ton unit WO₃)

High—\$287/metric ton unit WO₃ (\$260/short ton unit WO₃)

Concentrates:

Low—\$265/metric ton unit WO₃ (\$240/short ton unit WO₃)

High—\$276/metric ton unit WO₃ (\$250/short ton unit WO₃)
